

**SOUTH CAROLINA EDUCATIONAL BROADBAND  
SERVICE COMMISSION**

Meeting Minutes  
September 22, 2008

**Opening:**

The first regular meeting of the SC Educational Broadband Service Commission was called to order at 10:00am on September 22, 2008 at 1401 Senate Street, Room 115 by Neil Mellen. Mr. Mellen asked that it be recorded that a Public Announcement of the meeting was posted on Thursday, September 18, 2008 and Public Notice was provided to the Media.

**1. Introductions**

Commission members introduced themselves via round table and phone.

Cathy Hazelwood of the SC Ethics Commission informed the commission members that they would be governed by the Ethics Act. Ms. Hazelwood provided members with a copy of her overview of “The Ethics, Government Accountability, and Campaign Reform Act of 1991” and explained how the Act applied to them as commission members. Ms. Hazelwood then entertained questions from the members.

#### **4. Election of Commission Leadership**

##### **a. Authority of chairperson:**

The commission members agreed that the “chairperson” of the commission should be given the following authority:

- Authority to interact with Legislators.
- Authority to talk with a Consultant (Consultant must be approved by the commission).
- Authority to seek or speak with Legal Counsel.
- Authority to call and schedule commission meetings.

Once the commission agreed on the authority of the chairperson, a motion was made for nominations of a chairperson. Neil Mellen nominated Gary Pennington for Commission Chairperson. Neil Mellen felt that Mr. Pennington, having served on the SC Broadband Technology and Communications Study Committee as well as having a technical and legal background, was a good candidate for the position of chair. No other nominations were made and the commission unanimously voted to accept Gary Pennington as Chairman. It was agreed that the commission was also required to have a Vice Chairperson. William Byrd nominated Dr. Joachim Taiber as commission Vice Chairperson and made a motion in this regard. All members agreed and the motion was passed.
